**SUBJECT:** Crystalline Silicon Photovoltaic Cells, Whether or Not Assembled Into Modules, from the People's Republic of China: Extension of Preliminary Determinations in Circumvention Inquiries

---

On April 1, 2022, the Department of Commerce (Commerce) published notice of its initiation of circumvention inquiries with respect to the antidumping and countervailing duty orders on crystalline silicon photovoltaic cells, whether or not assembled into modules, from the People's Republic of China and the countries Cambodia, Malaysia, Thailand, and Vietnam.<sup>1</sup> In accordance with 19 CFR 351.226(e)(1), the current deadline for Commerce to issue its preliminary determinations in these circumvention inquiries is August 29, 2022. However, pursuant to 19 CFR 351.302(b), “{u}nless expressly precluded by statute, the Secretary may, for good cause, extend any time limit... .”

On August 11, 2022, Auxin Solar, Inc. (Auxin) requested that Commerce extend the deadline for issuing the preliminary determinations in these circumvention inquiries in order to fully develop and complete the records of the inquiries.<sup>2</sup> Additionally, not only are there numerous complex methodological issues present in these inquiries, but each inquiry also has a voluminous administrative record, including multiple questionnaire and supplemental questionnaire responses and comments submitted by interested parties, which Commerce needs additional time to analyze. Respondents have also requested numerous extensions of time to submit their

questionnaire and supplemental questionnaire responses.<sup>3</sup> Accordingly, for the above-mentioned reasons and in accordance with 19 CFR 351.302(b), we are hereby extending the deadline for issuing the preliminary determinations in these circumvention inquiries by 90 days, until **November 28, 2022.**<sup>4</sup>
